#### ROLE

- Gather & analyze critical data on road accidents; Conduct policy research on state/national/international policies and laws on road safety
- Identify issues with pre-existing regulations and provisions + formulate sound legislative policies/provisions on the RTSB & GSL, respectively.
- Lay the ground research work on subject matter for engaging with Parliamentarians
- Synthesize research findings into compelling reports, fact sheets, papers and articles for the consumption of SLF's international stakeholders, policy makers, media and international agencies and public among others
- Keep abreast with the latest research, policy/legal related news on road safety and emergency care
- Invoke and utilize the mechanism under the RTI Act to gather crucial data on road accidents, road safety and emergency medical response

- Assist the Policy and Advocacy team in day to day project coordination
