
Kindly refer to your office letter No. nil dated 08-12-2014, on the subject cited above.

2. In this connection, the matter was enquired through the Superintendents of Police Shimla & Kangra. As per the report received from Superintendent of Police Shimla, vehicle No. HP63B-2395 (Truck) has been challaned U/S 190 of Motor Vehicle Act whereas vehicle No. HP-63C-2325, was not found register at Regional Transport Office Shimla. Vehicle No. HP-11B-3339 has been found registered in the RTO office Solan and the enquiries are being made regarding the owner of vehicle from the concerned office. Further action will be taken on receipt of the name and address of the owner.

3. The Superintendent of Police, Kangra has intimated that the owner of truck No. HP 68-2315 has been advised not to repeat the commission of such offence. Necessary directions have been issued by them to all Station House Officers & Traffic Units in their respective jurisdictions for strict implementation of the violation of above amended Rules.



उपरोक्त विषय व संदर्भान्वये तक्रारदार श्री पियुश तिवारी, संस्थापक व अध्यक्ष, सेव्ह लाईफ फाऊन्डेशन, नवी दिल्ली यांनी मा. पोलीस महासंचालक, महाराष्ट्र राज्य, मुंबई यांस महाराष्ट्र राज्यातील विविध ठिकाणच्या राष्ट्रीय महामार्ग, राज्यमार्ग तसेच अन्य मार्गावर हलक्या, जड व अवजड वाहनांतून क्षमतेपेक्षा जास्त लांबीचा माल धोकादायकरित्या वाहून नेत असल्याने व मार्गात धोकादायकरित्या अशी वाहने उभी करून ठेवल्यामुळे मोठ्या प्रमाणात गंभीर अपघात होत असल्याची तक्रार केली आहे. या समस्येबाबत "सत्यमेव जयते" या मालिकेद्वारे प्रसार माध्यमांकडूनही व्यथा मांडण्यात आली आहेत. अर्जदार यांनी त्यांच्या संस्थेच्या स्वयंसेवकांमार्फत राज्यातील विविध मार्गावर सर्वेक्षण करून अशा वाहनाचे नोंदणी क्रमांक तसेच छायाचित्रे प्राप्त केली असून ती या सोबत जोडली आहेत.

मोटर वाहन कायदा १९८८ मधील कलम-१९० अन्वये असलेल्या तरतूदीनुसार कसूरदार वाहन चालकांवर कठोर दंडात्मक कारवाई करणे आवश्यक आहे. मो. वा. का. १९८८ कलम-१९० अन्वये कारवाई करण्याचे अधिकार महामार्ग पोलीस विभागास नाहीत. परंतु आपल्या सहकार्याने संयुक्तीक विशेष मोहिमांचे आयोजन करून कसूरदार वाहन चालकांवर कारवाई करणे शक्य होईल.

तरी आपण आपल्या अधिपत्याखालील प्रादेशिक परिवहन कार्यालयांतील अधिकाऱ्यांना जड-अवजड वाहनांतून क्षमतेपेक्षा जास्त लांबी-रुंदीचा माल धोकादायकरित्या वाहतूक करणाऱ्या वाहनांवर व मार्गावर धोकादायकरित्या उभ्या करून ठेवलेल्या अशा वाहनांवर कायदेशीर कठोर दंडात्मक कारवाई नियमितपणे करणेबाबत सूचना देण्यात याव्यात, ही विनंती.

**Subject: Advisory on strict implementation of Amended Rule 93(8) of the Central Motor Vehicle Rules, 1989 –Regarding.**


Sir/Madam,

India has reported the highest number of fatal road accidents in the world, which is a matter of serious concern. Many dangerous/fatal accidents take place because of vehicles carrying loads of protruding rods and other protruding materials. The Government of India, Ministry of Road Transport & Highways, vide its Notification G.S.R. 152 (E) dated 5<sup>th</sup> March 2014 has deleted the proviso to Rule 93(8) of Central Motor Vehicle Rules, 1989, with the result that no goods carrier is permitted to carry any load, which is protruding outside the vehicle. The law now effectively bans trucks from carrying protruding rods and other dangerous, protruding material, while moving or in a stationary position. Contravention of the said rule is a punishable offence under the Motor Vehicles Act, 1988. The violators should, therefore, be prosecuted under Section 190 of the Motor Vehicle Act, 1988. The law also provides for a hefty fine on the owners and consignors of trucks.

2. The Save Life Foundation, an NGO, has addressed letters to all the States/UTs requesting for a ban on the plying of such vehicles which cause deaths and serious injuries to the road users and for taking strict action against the defaulters. The NGO has also furnished State-wise documentary proof with photographic evidence of the violations indicating the Vehicle No., Date & time. The NGO has also sent letters to the DGP/Commissioners of all the States & UTs highlighting the ban that has been imposed by law and recommending swift action.

3. The Union Government attaches the highest importance to this issue and urges the State Governments/UT Administrations to strictly ensure that no vehicle should be allowed to carry protruding loads and other dangerous, protruding materials and strict action should be taken against the violators under the appropriate laws.

उपरोक्त विषयान्तर्गत लेख है कि केन्द्रीय मोटर वाहन नियम 1989 के नियम 93(8) में मोटर वाहनों में भार को वाहन की बॉडी से बाहर निकालने पर प्रतिबन्धित किया हुआ है। सडक परिवहन और राजमार्ग मंत्रालय, भारत सरकार की अधिसूचना दिनांक 05-03-2014 द्वारा इस नियम के परन्तुक में उपनियम (8) को लोप किया गया है जिसके अनुसार अब खम्भे, सरिये आदि अविभाज्य भार का वाहनों की बॉडी से बाहर निकला होना भी नियम विरुद्ध है। इस नियम का उल्लंघन करने वाले वाहनों के विरुद्ध मोटर वाहन अधिनियम 1988 की धारा 190 में सजा का प्रावधान है।

सडक सुरक्षा के क्षेत्र में कार्यरत संस्थान "सेव लाईफ फाउन्डेशन" नई दिल्ली ने राजस्थान के विभिन्न शहरों में उक्त प्रावधान का उल्लंघन करते पाये गये कुछ वाहनों की 2 सूचियाँ मय फोटो ग्राफ्स के इस कार्यालय को भिजवाई हैं तथा उनके विरुद्ध नियमानुसार कार्रवाई करने की सिफारिश की है। उन्होंने वर्ष 2012 में राज्य में ट्रकों के बाहर निकले हुए सरियों से होने वाली दुर्घटनाओं से 185 लोगों की मृत्यु तथा 635 लोग घायल होना दर्शाया है।

अतः अपने-अपने क्षेत्राधिकार में वाहन की बॉडी से बाहर निकले हुए सरिये, खम्भे व लोहे के ऐंगिल आदि परिवहन करते पाये जाने वाले वाहनों के विरुद्ध सख्त कार्रवाई की जाकर जन-धन की हानि को रोका जावे।


